Building on Susan B. Anthony's Legacy Title IX at 45



"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance.

Title IX, Education
 Amendment of 1972

Historical Context

Although the Civil Rights Act of 1964 was written in order to end discrimination in various fields based on sex, religion, race, color, or national origin, the Act did not prohibit gender discrimination in public education and federally assisted programs. In 1967, President Lyndon Johnson sent a series of executive orders to clarify parts of the Act—notably Executive Order 11375, which required all entities receiving federal contracts to end discrimination on the basis of sex in hiring and employment.

Through the '60s and early '70s, there were several congressional hearings in which women's rights were discussed, and it was in one of these congressional hearings that Title IX was first proposed. An early draft was authored by House Representatives Patsy Mink and Edith Green. In preliminary drafts, the focus was on the hiring and employment practices of federally financed institutions, with little mention of athletics.

The proposed provision that would eventually become Title IX was introduced in Congress by Senator Birch Bayh of Indiana in 1971, who was its chief Senate sponsor throughout debate. Title IX became law on June 23, 1972. When President Nixon signed the bill, he spoke about desegregation busing, but did not mention the expansion of educational access for women.

Impact of Title IX

Title IX requires gender equality in all aspects of publicly-funded education. Although Title IX is best known for breaking down barriers in sports for women and girls, it also opened the door

for girls to pursue math and science, required fair treatment for pregnant and parenting students, and protected all genders from bullying and sexual harassment.

In 2014 and 2016, guidelines were issued by the U.S. Department of Education stating that transgender students were also protected from sex-based discrimination under Title IX, and these guidelines instructed public schools to treat transgender students consistent with their gender identity, rather than gender at birth.

In February 2017, the departments of justice and education under the Trump administration withdrew the guidance on gender identity issued by the Obama administration.

More recently, Title IX is again in the news. This July, Betsy DeVos, the Secretary of Education said that she was thinking of rewriting the rules regarding sexual assault on college campuses, and would be holding listening sessions with victims, students who had been accused, and higher-education officials. More recently, DeVos said she would be opening a public comment period—which is the step taken before a government agency issues new guidelines.

Equality Day at the National Susan B. Anthony Museum & House

On August 26 we celebrated Equality Day at the Anthony Museum. National Women's History Project writes, "The date was selected to commemorate the 1920 certification of the 19th Amendment to the Constitution, granting women the right to vote. This was the culmination of a massive, peaceful civil rights movement by women that had its formal beginnings in 1848 at the world's first women's rights convention, in Seneca Falls, New York."

"The observance of Women's Equality Day not only commemorates the passage of the 19th Amendment, but also calls attention to women's continuing efforts toward full equality."



Anthony and the 100th anniversary of woman suffrage in New York State.
